Minutes from a meeting of the Parish Council, held on Tuesday May 2nd 2017 at 7pm.

ELECTION OF CHAIR / VICCE CHAIR

- Cllr Rabbette was nominated chair – proposed Cllr Edwards, seconded Cllr Gough – no objections
- Vice Chair was deferred to next meeting

1. **DECLARATIONS OF INTEREST** – None were declared

3. **PROGRESS REPORTS**

a) Highway Matters

- Speeding / Speed Data – Deferred to next meeting. The clerk was asked to remind Mr Smithson to supply us with a simple analysis or attend the next meeting so that the parish council can move forward with this
- Pool Close – road surfaces in need of maintenance – Clerk to chase County Council
- Verge outside the church – It was agreed we ask the LM to clear the mud of the existing footpath alongside the verge in the first instance.

b) Footpaths/Rights of Way

- Footpath adjacent to Church / Furrows End – To defer until Cllr Morris returns from holidays
- Footpath rear of Brookfields – styles to be replaced by CC, with agreement from the landowner

c) Lengthsman - The clerk will ask the LM to keep Manor Lane tidy where necessary in readiness for the Street Market, and the verge outside the church.

d) Planning:
